# B9+ Priorities for Regulatory Simplification

## Business (the B9+) is working with D9+ & EU



## B9+ Vision for a Digital Europe, 2024-2029

A Europe that can access and safeguard the economic benefits of further digital transformation:

- 1. From a Strong and Effective Internal Market
- 2. By being **Open** to international co-operation and trade while encouraging capacities across Europe
- 3. Securing Competitiveness and Resilience with strong business Conditions and digital Capacities (to connect, adopt, innovate and trade)

## Regulatory Simplification (1)



#### General

- "We need less paperwork, less overlaps, less complex rules", President von der Leyen in State of the Union, 2025[1]
- Promote Innovation & Competitiveness. Reduce administrative burden & cost. Ensure harmonised application of rules
- Remove administrative requirements that don't enhance protection of consumer/society
- Simplify rules (AI, Data, Cyber)[2] support compliance and competitiveness.
- Consider 'regulatory innovation'[3]
- Simplification should be an ongoing process[4]

#### Data

- Safeguard security and trade secrets in the DA/DGA. Facilitate voluntary data sharing
- Explicitly recognise proportionality and a riskbased approach in the GDPR, especially in Al use[5]
- Clarify the interaction between EU digital rules[6] and simplify data sharing requirements. Remove inconsistencies that create uncertainty for investments.
- Encourage data flows. Make Adequacy simpler. Provide guidance on transfers to third countries

## Regulatory Simplification (2)



#### Al

- Support legal certainty, reduce risk to foster investments and innovation
- Further clarity on definitions in the EU Al Act
- Apply high risk requirements after relevant harmonised standards are published, allowing sufficient time for adaptation.[1]
- Reduce administrative requirements for high-risk AI that do not proportionately increase the protection of consumers or society[2]

#### Cyber security & resilience

- Avoid duplicate reporting obligations
- Create single national entry point for incident & cybersecurity reporting (including GDPR)
- Introduce common reporting templates
- Encourage controlled sharing of sensitive information
- Increase meaningful stakeholder participation in the certification process. [3]
